## Content

 $\Box$  Include an acknowledgement slide identifying any relevant stakeholders and contributors

□ Include an affiliation slide (e.g., University of British Columbia)

□ Include a conflict of interest slide (i.e., presenters must disclose any conflict of interests or if there are none, clearly indicate this on the slide)

□ Answer the following key questions:

□ <u>Situation</u> – Describe the situation

□ <u>Background</u> – Provide a background of the practice setting

□ <u>Assessment & Action</u> – Describe your experiences during COVID-19. Here are some guiding questions:

- What were the challenges you encountered and how did you overcome them?
- What successes did you achieve?
- What partnerships developed as a result? How was the partnership beneficial and how did you leverage the connection made in order to create positive outcomes?

<u>Recommendation</u> - If you were to face a similar challenge in the future, what top 3-5 lessons would you share with your future self, based on what you have learned from COVID-19?
